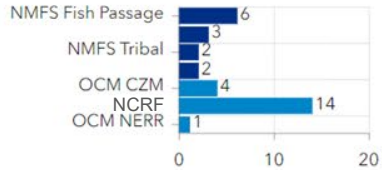

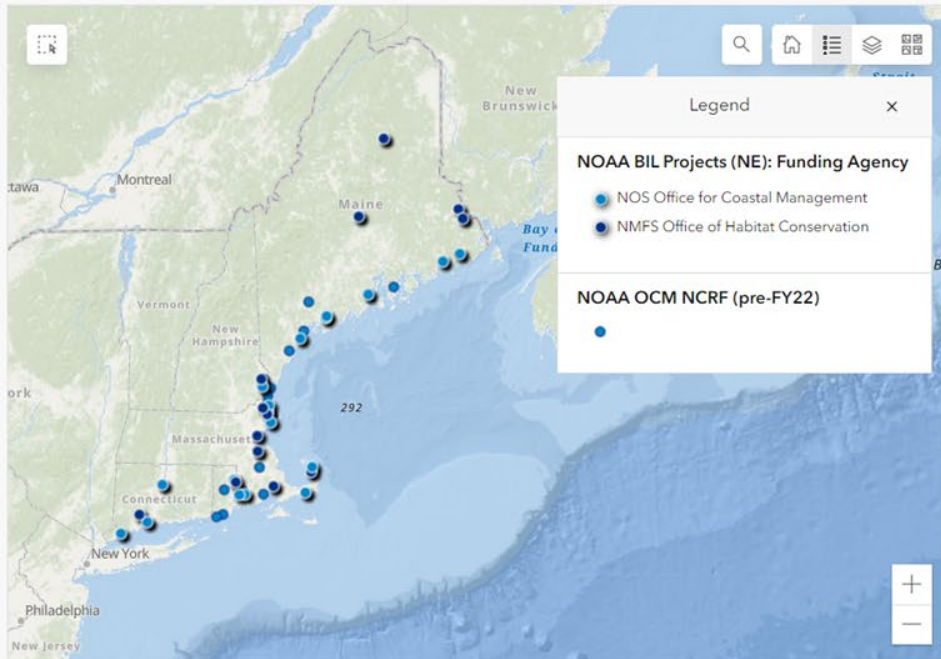

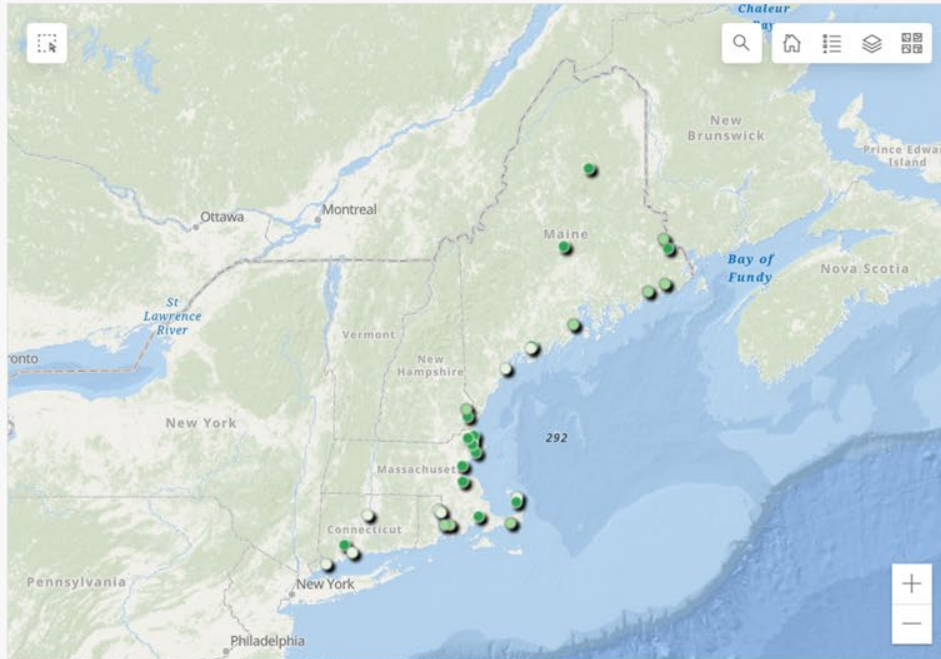

# NOAA Fisheries BIL Competitions Still Open

- Restoring fish passage through barrier removal grants (\$175M with another \$85M for tribes)
  - Regular applicant project range \$1-20M. Deadline: 10/16
  - Tribal project range \$300K-12M. Deadline: 11/8
- Transformational habitat restoration and coastal resilience (\$240M)
  - \$1-25M over 3 years. Deadline: 11/17
- Habitat restoration and resilience for tribes and underserved (\$45M)
  - \$75K-3M over 3 years, Deadline: 12/19



# NOAA's Climate Resilience Regional Challenge

## (funded by Inflation Reduction Act)

- Approximately \$575 million for projects that build resilience of coastal communities to extreme weather and other impacts of climate change.
- NOAA received 869 eligible letters of intent requesting ~\$16B in funding. We selected 120 applicants to submit full proposals. Total requested funding requested in those full applications is ~\$3B.









# Inflation Reduction Act: NOAA funding opportunities



- **Climate Resilience Regional Challenge (\$575 million)**
- Ocean-based Climate Resilience Accelerators (\$100 million) just closed
- Climate Ready Workforce (\$60 million) closes 11/30

# Climate Ready Workforce (\$60 million)

- Assist communities in coastal and Great Lakes states, territories and tribes so they may form partnerships that train workers and place them into jobs that enhance climate resilience
- Between 10-20 awards under this competition, at amounts ranging from \$500,000-\$10 million each
- Letters of Intent due November 30, 2023
